### D.4: How do I do life to life relationships [2 Timothy 3:10-16]

What is Man to Man (M2M)? This is an expression representing one person connecting with another person to share their lives and insights with one another. Usually this mean there is a person who has matured further in their spiritual life and has the intent to pass that experience and knowledge of the word of God to the other person. It implies that the other person is open to that relationship and is teachable.

Yet the Lord rescued me from all of them. <sup>12</sup>In fact, everyone who wants to live a godly life in Christ Jesus will be persecuted, <sup>13</sup>while evildoers and impostors will go from bad to worse, deceiving and being deceived. <sup>14</sup>But as for you, continue in what you have learned and have become convinced of, because you know those from whom you learned it, <sup>15</sup>and how from infancy you have known the Holy Scriptures, which are able to make you wise for salvation through faith in Christ Jesus. <sup>16</sup>All Scripture is God-breathed and is useful for teaching, rebuking, correcting and training in righteousness...”*
